## **DIRECTIONS TO DERMODY, BURKE & BROWN'S OFFICES**

### **SYRACUSE**

**443 North Franklin Street, Syracuse, NY 13204 - 315.471.9171**

#### ***FROM THE NORTH***

Take I-81 South to the Franklin/West Street exit. At the first traffic light, turn right on North Franklin Street. Our office is the second building on the left-hand side of the street.

#### ***FROM THE SOUTH***

Take I-81 North to the Court Street exit (#22). Bear left off the exit ramp. At the stop sign, turn left on Court Street; take Court Street all the way to the end. Turn left on Solar Street; take Solar Street all the way to the end. Turn left on Plum Street. At the corner Plum Street ends and you will be on North Franklin Street. Our office building will be on your immediate right.

#### ***FROM THE EAST***

Take I-690 West to I-81 North. Exit at Court Street (#22). Bear left off the exit ramp. At the stop sign, turn left on Court Street; take Court Street all the way to the end. Turn left on Solar Street; take Solar Street all the way to the end. Turn left on Plum Street. At the corner Plum Street ends and you will be on North Franklin Street. Our office building will be on your immediate right.

#### ***FROM THE WEST***

Take I-690 East to the West Genesee Street exit. Turn left off the exit on West Genesee Street. At the intersection of West Genesee Street and North Franklin Street, turn left. After the third traffic light (will go under a bridge just prior to this light), turn left on North Franklin Street. Our office is the second building on the left-hand side of the street.

### **AUBURN**

**1120 Corporate Drive, Auburn, NY 13021 - 315.253.6273**

#### ***FROM THE EAST***

Take I-690 West until Auburn exit, #6. Bear to the right and get on Routes 5 & 20 West. Stay on 5 & 20 for approximately 15 miles. Turn left onto Corporate Drive before Wendy's Restaurant. Our office is the 3rd building on the right.

#### ***FROM THE WEST***

Take Routes 5 & 20 East. When you enter Auburn, this road will become Grant Avenue. Turn right after Wendy's Restaurant onto Corporate Drive. Our office is the 3rd building on the right.

**New Hartford**

***FROM THE EAST***

Take Thruway to Exit 31 (Utica).

Follow signs for Route 12 South.

Continue past Sangertown Mall and various fast food restaurants

At Zebb's intersection take left onto Middle Settlement Rd

Office is about 1/2 to 3/4 mile on the left hand side of the road (Dove Medical Park).

Once in the lot, DBB office is to the right.

***FROM THE WEST***

Take Thruway to Exit 32 (Westmoreland)

Once through tollbooth take right on Cider Street

At light, take left on to Rt. 233.

Follow Rt. 233 to Rt. 5 (Nice 'n Easy on the left side)

Take left on to Rt. 5.

At Pizza Hut/Zebb's intersection, take right on to Middle Settlement Rd.

Office is about 1/2 to 3/4 mile on the left hand side of the road (Dove Medical Park).

Once in the lot, DBB office is to the right.
